

COVID-19 mRNA: It Is Nowhere To Be Found – Game Over!

The COVID-19 virus is claimed to be in the air (presumably everywhere); however, no evidence of its presence or existence has been provided except for computer-generated photographs. The assertion is that considering its minuscule (submicroscopic) physical size and quantities, it can only be shown with the computer or hand-drawn sketches.

Experts believe that the virus is killing people. Therefore, it (the invisible one) must be eliminated/killed to save people and humanity from dying.

The recommended treatment is mRNA (medicine, a chemical called messenger ribonucleic acid) in the form of a vaccine. The promoted mRNA's working principle is based on producing a specific protein (spike protein) in the body to develop immunity against the virus.

It is not commonly recognized that a vaccine is ***not*** the treatment but a vehicle to deliver the mRNA into the body, which is the treatment. It is like a tablet, capsule, or suspension is not a medicine but a package containing the medicine (the active ingredient) to deliver it conveniently and accurately into the body. A more straightforward example to explain the concept, i.e., vaccine vs. mRNA, is that candy is not sugar but contains sugar.

Similarly, the vaccine is not mRNA but (should) contain mRNA. The point is that do not consider the vaccine and mRNA the same;

they are very different. There could be other ways to administer mRNA besides a vaccine, but the mRNA is needed as medicine. A vaccine (product) cannot be manufactured until mRNA is available independently.

So, where is the mRNA, isolated, purified, and characterized, in a vial or test tube? Unlike viruses, it is claimed to be commercially manufactured in large quantities and should be available in vials or test tubes like other medicines and chemicals.

mRNA cannot be invisible, unmeasurable, or unquantifiable; it is claimed to be physically produced in large (gram) amounts. Sorry, it is unavailable from anywhere. So, the mRNA does not exist - ***prove me wrong!***

In literature, one hears about the production or manufacturing of mRNA vaccines but not the mRNA. In reality, it should be the mRNA first. One does ***not*** find a reference to mRNA in the literature (its isolation, purification, and characterization). Therefore, from a scientific/therapeutic perspective, the vaccine remains a concoction (of unknown nature or gunk), which may or may not contain the claimed mRNA.

From my literature search, it can confidently be stated that mRNA for vaccines does not exist like the virus ([link](#)). As explained earlier, the so-called mRNA vaccine is a selectively concentrated cell culture (gunk) of unknown nature ([link](#)). It could be very toxic, hence commonly observed adverse effects, including
