



## Missing Science From Viruses, Vaccines And Medical/Pharmaceutical Practices

I have worked in medicines/pharmaceutical areas for almost 40 years, including 30 years as a Research Scientist at Health Canada. My research involved developing, validating, and applying tests related to pharmaceutical product evaluations for regulatory assessment purposes. I have contributed to medicine, primarily chemicals, as any other scientist in chemistry, such as publications in peer-reviewed journals, participated in and led scientific conferences worldwide, and received awards.

Based on my expertise, I have expressed my concerns clearly and openly about the lack of science in pharmaceutical product assessments. In short, claims made by regulatory authorities, including the FDA and Health Canada, about product safety, efficacy, and quality may be regarded as invalid, false, and fraudulent.

The reason for this claim is that the assessment and approval, in general, are done under the guidance of medical (primarily physicians) and pharmaceutical experts who lack training and experience in the underlying science/chemistry, in particular analytical or testing, and make scientifically invalid and false claims.

Four years ago, the world entered the COVID-19 pandemic. The claim is based on tests or testing, commonly known as PCR, that falls in my expertise. Looking into the testing science aspect, it immediately became clear that the test and pandemic were fraudulent.

The reason the PCR test is false and invalid is that for a test, any test, to be valid, it must be validated against a reference standard, in this case, the virus (SARS-COV-2). Looking into the literature, particularly from the CDC/FDA, it became clear that no virus specimen is available. Hence, the PCR test, by definition, became scientifically invalid and a fraud.

Why is the alleged illness or the pandemic if the virus is unavailable? It can't be! The question is why the virus sample is unavailable when it is claimed that it has been isolated. It was determined that the medical experts, virologists, and microbiologists do not use the word isolation in its well-accepted meaning but assume that if the swabs are mixed with a medium and perform cell culturing, it is considered that the virus has been isolated.

A smaller portion of the culture medium (a soup or gunk) is considered an isolated (or "purified") virus. It is certainly a misrepresentation of science and amounts to cheating and

falsification. Therefore, it confirms that there has never been a virus, and the experts have never worked with it.

The extension of the fake (virus/pandemic) story is that there has never been any scientific research done concerning gain of function research or establishing the virus's origin because any research requires an isolated and pure sample of the virus, which is unavailable anywhere. Hence, all claims become fake and false.

A more bizarre is the fact that vaccines have been developed against a non-existing virus and its illness, which is based on utterly fake science ([link](#)).

All these observations and conclusions are external to the medical or pharmaceutical areas but based on purely centuries-old, well-established fundamental science subject – chemistry. Practically, all rules and assumptions of science have been violated, with the rationale that this is how "science" is done in the modern day and the medical field.

Based on actual science (chemistry) considerations, I provided convincing arguments against the virus's nonexistence, invalid (PCR, antigen, etc.) testing, fake pandemic, and failed vaccine developments ([link](#)).

The question is why science has not been followed. The simple reason is that medical experts (physicians) do not study science in their learning and training. Doctor of Medicine is a non-science undergraduate degree ([link](#)) without laboratory research training or expertise in science. Their understanding of science is self-created assumptions and beliefs, more like rituals, not science.

An independent third party, preferably experts in science/chemistry (testing), is urgently needed to audit and address the false claims made in medical practices and related (pharmaceutical) product development, manufacturing, and assessment.
